Design Organisation Approval Certificate EASA.21J.112

1 Scope of approval

This Design Organisation Approval has been granted for:

 - 2. to approve minor changes to type certificate and minor repairs;
 - 3. to issue information or instructions containing the following statement: "The technical content of this document is approved under the authority of DOA ref. EASA.21J.112";
 - 4. to approve minor revisions to the aircraft flight manual and supplements, and issue such revisions containing the following statement: "Revision No [YY] to AFM (or supplement) ref. [ZZ], is approved under the authority of DOA ref. EASA.21J.112.";
 - 5. to approve the design of major repairs to products for which it holds the type-certificate;
